Our Voter Guide has a few sections, including key dates, explaining what Prop 50 is, and how it got on the ballot. Here are some highlights:

- Our <u>redistricting map</u>, where readers can enter an address to see how their district will change if Prop 50 is passed.
- We have a <u>new FAQ page</u> with general voting information for readers anywhere in the state. To republish the FAQ, hit the "Republish" button on the page to grab the code.
- The "Funder" section shows top fundraisers for and against Prop 50.
- We also have guest commentaries both for and against Prop 50.
 Please mark clearly as OPINION or COMMENTARY if you share or republish. These pieces are not representative of the stance of CalMatters.
 - For: As checks and balances fade, Prop. 50 gives Californians a chance to hold the line by Trena Turner, who served on the California Citizens Redistricting Commission in 2020.

 Against: Why California voters should reject Prop. 50 and stay out of the redistricting wars by Jeanne Raya, who was the chair of California's first independent redistricting commission.
